7. What are some of the key terms and conditions that I should be aware of?

- **Duty of Disclosure**
Consumer Insurance Contract
Pursuant to Schedule 9 of the Financial Services Act 2013, you must take reasonable care to ensure that all your answers to the questions are to the best of your knowledge, full, complete, correct and honest. You also have a duty to inform us of any change in the details or information given to us before we issue the policy to you, or before you renew or change any of the terms of your policy. If you fail to do so, your policy may be cancelled or treated as if it never existed, or your claim may be rejected or not fully paid.
- **Change in Risk**
If there are changes occur at any time or from time to time, and materially vary any of the facts provided at the date of the proposal, you shall give notice in writing to us within seven (7) days from the date of change and shall pay additional premium if it is required.
- **Cash Before Cover**
Full premium must be paid before the effective date of the Policy.
- **Premium Payment**
Payment can be made by Debit Card, Credit Card or Online Payment to Berjaya Sampo Insurance Berhad. Please keep a receipt of the premium paid as the proof of payment for future reference.
- **Claims Procedure**
Written notice must be given to us within thirty (30) days from the date of occurrence. You may submit your claims by emailing us at customer@bsompo.com.my or visit any of our branches nationwide.

Only Death or Permanent Disablement will be payable if you reside or travel outside Malaysia, Singapore, Brunei and Thailand for more than ninety (90) consecutive days.

Documents Required for Unauthorised Transaction of e-Wallet:

- A written complaint made to Touch 'n Go containing complete details of unauthorised transaction;
- Touch 'n Go transaction history statement with Insured Name;
- A copy of police report;
- Bank/credit card statement consisting of transaction details with Insured Name;
- All other information and documentary evidence that we may require.

Documents Required for Unauthorised Transaction of Bank Account:

- A written complaint made to the Bank containing complete details of unauthorised transaction;
- A copy of police report;
- Bank statement consisting of transaction details with Insured Name;
- All other information and documentary evidence that we may require.

Documents Required for claim filed by insured persons with Hazardous Occupations:

- A written letter from the insured's commanding officer or supervisor to confirm that he or she is off duty at the time of accident occurs;
- A copy of incident or police report;
- Certified leave or duty roster;
- All other information and documentary evidence that we may require.

8. What are the major exclusions under this Policy?

This Policy does not cover losses which are specifically excluded under the Policy, for example, any pre-existing physical or mental defect or infirmity, suicide or attempted suicide, intentional self-injury, and influence of alcohol or drug, etc.

This Policy does not cover the following Hazardous Occupations, when You are on duty at the time a claimable event occurs.

- Naval, Military or Airforce Service Operations
- Air Crew
- Professional Sportsperson
- Ship Crew and Professional Divers
- Policeman / Traffic Police
- Jockey
- Fireman
- Shipyard Worker

9. Can I cancel my Policy?

You may cancel your Policy by giving us a written notice. Upon cancellation, we will retain minimum premium of RM60.00 and refund the pro-rated premium to you. However, premium will not be refunded if there was a claim paid or submitted to us during the Policy period.
