

Count the Sompony Contest 2024 TERMS AND CONDITIONS

The Count the Sompony Contest 2024 ("Contest") is organised by Berjaya Sompo Insurance Berhad ("BSIB") by the terms and conditions ("Terms and Conditions") stated herein.

ELIGIBILITY CRITERIA

- 1. The Participant must be residing in Malaysia, aged eighteen (18) years and above.
- 2. Persons who have committed or who are suspected of having committed any fraud, unlawful or wrongful acts in relation to any business conducted with BSIB during the Contest Period, are NOT eligible to participate in the Contest.
- 3. Participants may be required to submit further proof of their eligibility within such timeframe as may be required by BSIB, failing which BSIB shall be entitled to disqualify the Participant.
- 4. Eligible participants exclude employees of BSIB.

GENERAL TERMS AND CONDITIONS

- 13. These Terms and Conditions shall be governed by and construed by the laws of Malaysia.



CONTEST MECHANICS

1. The Contest Post shall commence on 1 April 2024 and will end on 30 April 2024, 11.59 pm ("End Date"), both dates inclusive ("Contest Period").

 - (c) in BSIB's sole determination, it believes that the Participant attempted to undermine the operation of the Contest by fraud, cheating or deception.
