FREQUENTLY ASKED QUESTIONS - TO HELP YOU UNDERSTAND THE COVERAGE BETTER

1. Who can be insured?

Any persons who are residents in Malaysia and having Student Pass or Employment Pass/Work Permit legally employed in Malaysia, who are three (3) to seventy (70) years old.

2. What is the period of cover and renewal options?

Duration of cover is for 1 year. You need to renew your Policy annually.

This Policy is renewable at the option of the Policyholder subject to terms and conditions at each Policy anniversary. Application for change to a higher/lower plan can only be made upon renewal and is subject to acceptance by Us.

3. Can I cancel my Policy?

You may cancel your Policy by giving us a written notice. Upon cancellation, we will retain minimum premium of RM60.00 and refund the pro-rated premium to you. However, premium will not be refunded if there was a claim paid or submitted to us during the policy period.

4. Who else can be covered under this policy other than myself?

- Your spouse;
- Your children; or
- Any other person who are the driver or passenger in your car

5. What is the maximum number of Person(s) Insured allowed to be covered under one Policy?

The maximum number of Person(s) Insured allowed is up to the seating capacity stated in your Vehicle Ownership Certificate (VOC).
