

“HUNT FOR HAPPINESS” CONTEST TERMS AND CONDITIONS

This Hunt for Happiness Contest (“**Contest**”) is organised by Berjaya Sompo Insurance Berhad (“**BSIB**”) in accordance with the terms and conditions (“**Terms and Conditions**”) stated herein.

ELIGIBILITY CRITERIA

1. The Participant must be a Malaysian aged eighteen (18) years and above, residing in Malaysia.
2. The following persons are NOT eligible to participate in the Contest:
 - a) Persons holding permanent residency status in Malaysia;
 - b) Employees of BSIB or related companies, and their immediate family members (spouse, children, parents or siblings); and
 - c) Persons who have committed or who are suspected of having committed any fraud, unlawful or wrongful acts in relation to any business conducted with BSIB during the Contest Period.
3. Participants may be required to submit further proof of their eligibility within such timeframe as may be required by BSIB, failing which BSIB shall be entitled to disqualify the Participant.

GENERAL TERMS AND CONDITIONS

1. Participants shall read these Terms and Conditions before participating.
2. By submitting the Contest Entry, Participants shall be deemed to have read, understood, accepted and agreed to be bound by the Terms and Conditions of the Contest.
3. BSIB reserves the right to vary, postpone or re-schedule the dates of the Contest or extend the Contest Period at its sole discretion.
4. BSIB may terminate or suspend the Contest at any time at its absolute discretion in which case, BSIB may elect not to award any Prize. Such termination or suspension will not give rise to any claim by the Participants. If the Contest is resumed by BSIB, Participants shall abide by BSIB’s decision regarding resumption of the Contest and disposition of the prizes.
5. Participants shall not be entitled to claim any compensation from BSIB for any losses and damages suffered or incurred, either directly or indirectly, due to any representations, amendments, alterations or modifications of the Terms and Conditions of the Contest, including cancellation, termination or suspension of the Contest, which remains at the sole discretion of BSIB.

6. BSIB's decision on all matters relating to the Contest shall be final, conclusive and binding on the Participants and no appeal against its decision will be entertained.
7. All information, including personal information or data submitted to BSIB in connection with the Contest will only be used for the purposes set out in and treated in accordance with these Terms and Conditions, the Personal Data Protection Act 2010 and BSIB's Privacy Notice, which is available at <https://www.berjaysompo.com.my/page/privacy-notice>.
8. By participating in the Contest and submitting the Contest Entry, Participants consent and agree that BSIB is entitled to collect, process and use the personal data submitted for the purpose of the Contest, including publishing the Participant's personal data (e.g. name, email address and photo) for publicity, promotional and advertising purposes of the Contest ONLY, without any compensation or need for prior notification to Participants.
9. BSIB will take all reasonable precautions to ensure that any third-party service provider involved in the Contest keeps the Participant's personal data secure and to be dealt with in accordance with the Personal Data Protection Act 2010 and BSIB's Privacy Notice.
10. Participants agree that where they are required to submit any photographs, drawings, pictures, slogans, materials or other creative works, including voice or video recordings (collectively "**Intellectual Property**") with the Contest Entry, the Participant warrants that all Intellectual Property Rights in such submission does not infringe any third party intellectual property rights.
11. Participants also agree and consent that BSIB shall have the right to broadcast the video recording submitted by Participants in the Contest Entry in whole or in part, at BSIB's absolute discretion.
12. Participants agree that Participants shall not by act or omission, directly or indirectly, bring BSIB into any disrepute.
13. Participants shall assume full liability and responsibility in case of any liability, mishap, injury, loss, damage, claim or accident (including death) resulting from their participation in this Contest and BSIB shall not be responsible for any liability, mishap, loss, damage, claim or accident (including death) in any manner whatsoever.
14. The contest will be conducted in the English language ("**Contest Language**").
15. These Terms and Conditions shall be governed by and construed in accordance with the laws of Malaysia.



CONTEST MECHANICS

1. The Contest shall commence on **30 June 2020** and will end on **20 July 2020, 11.59pm** ("End Date"), both dates inclusive ("Contest Period").

3. Participants must complete all questions to be eligible to participate in the Contest.
4. All costs and related expenses that are incurred to participate in the Contest and to redeem the Prizes are the sole responsibility of the Participant.
5. BSIB shall not be responsible for any Contest Entry not received due to any reason whatsoever.

CONTEST ENTRY

1. Participants need to do as below:

 - (d) Step 2: Insert a photo/video to support your answer.
Example: "I have learned how to cook a Japanese omelette during MCO #HuntForHappiness. (photo/video)"
2. Each Participant can ONLY submit one (1) Contest Entry during the Contest Period. Participants submitting multiple entries will be disqualified.
3. Any submission after the End Date will be automatically disqualified and ineligible for Prize consideration.
4. Entries submitted in the Contest Language only will be accepted.
5. The Contest Entry must be complete, accurate and sent to BSIB via the mode stated above, together with the photo/video as required.
6. Participants are prohibited from submitting Contest Entry with the following content:
 - (a) offensive, such as content that promotes racism, political and/or religious agendas;
 - (b) any form of seditious content, violence, foul language, bigotry, hatred or physical harm of any kind against any group or individual;

- (c) displays of obscene, pornographic or sexually explicit material of any kind;
- (d) harassments or advocates harassment of another person;
- (e) involves the transmission of “junk mail”, chain letters, spam or any other unsolicited mass mailing, e-mailing, or other communication;
- (f) includes any information that (1) the participant knows is false or misleading, (2) promotes illegal activities or conduct that is abusive, or (3) is threatening, obscene, defamatory, or libellous; or
- (g) exhibits overtly dangerous or potentially life-threatening situations.

DISQUALIFICATION

1. BSIB reserves the right to disqualify Participants and/or revoke the Prize (at any stage of the Contest) if:
 - (a) the Participant is ineligible or does not meet any of the Eligibility Criteria;
 - (b) the Participant breaches any of these Terms and Conditions, other rules and regulations of the Contest or violated any applicable laws or regulations; or
 - (c) in BSIB’s sole determination, it believes that the Participant attempted to undermine the operation of the Contest by fraud, cheating or deception.
2. In the event of a disqualification after the Prize has been awarded, BSIB reserves the right to demand for the return of the Prize from the disqualified Participant.

PRIZES

3. BSIB shall select reserve winner(s) in substitution of any of the forty (40) initially selected winners who may subsequently be disqualified for non-compliance with the Terms and Conditions of the Contest (“**Reserved Winner**”)

3. In the event the winner does not acknowledge the winning as required in BSIB's website winners' announcement page, BSIB reserves the right at its absolute discretion to award the Prize to a Reserved Winner instead.
4. All winners selected by BSIB shall be final.
5. BSIB shall send the Prize by courier to the winners, unless otherwise informed to the winners by BSIB and BSIB shall not be held responsible for any Prize which is lost, stolen or damaged by the courier service.
